PINE RIVER CARTS

Pine River Carts are available for use by members and guests at PRCC. Keys for the carts will be kept at the main desk in the clubhouse and provided to users only after signing in for play. Users are expected to share a cart when playing in the same group. Maximum of two club carts per foursome of players.

Per Person Rental costs are as follows:	9 holes or less	\$9.00/rider
	10 – 18 holes	\$18.00/rider

ANNUAL PRCC CART PLANS:

Cart usage is also available on an annual basis through purchase of a cart plan. An individual cart plan allows persons holding individual memberships to use one of the PRCC carts whenever the member wishes to play golf. The privilege is only available to the individual cart plan holder. Any other person riding with the plan holder must pay the rental fees set forth above. The plan holder is responsible for having the rider check in at the main desk and pay the required fees. Failure to do so will result in the rider's rental fee being charged to the plan holder, plus an additional \$10.00 administration fee.

A family cart plan is available to persons maintaining family memberships at PRCC and will allow any qualified family member to use a cart (only one cart on the course at any given time) at any time a family member wishes to play. Non-family members riding with a family member must still pay the rider fees set forth above. The primary holder of the family cart plan is responsible for seeing that all non-family riders check in at the main desk and pay the required fees. Failure to do so will result in the rider's rental fee being charged to the plan holder, plus an additional \$10.00 administration fee.

CART COUPONS FOR MEDALLION HOLDERS

Holders of Medallion Memberships may purchase a book of cart certificates for use by its designated members and/or its green fee paying guests. These certificates can not be transferred, sold or used by golfers other than the Medallion holder's designated employees and their guests. Any qualified person desiring to use one or more of the certificates to pay for cart rental MUST SURRENDER THE REQUIRED CERTIFICATE(S) AT THE MAIN DESK AT THE TIME OF USAGE. NO EXCEPTIONS! LOST CERTIFICATES WILL NOT BE REPLACED. ALL UNUSED CERTIFICATES EXPIRE ON DECEMBER 31ST.

TRAIL FEES

PRCC members that own their own golf carts may use those carts at PRCC by paying a trail fee. A person holding a single membership at PRCC may do so by paying a trail fee of \$495 per golf season. A person maintaining a family membership may do so by paying a trail fee of \$695. A personal cart allowed on PRCC through a single membership must be used by that member. A cart allowed on PRCC pursuant to a family membership must be used by any qualified member of the family. Any rider using the cart with a qualified user

shall not be required to pay any rider fee. Private carts may NOT be loaned to, or used by, third parties. A qualified user must be one of the persons using the cart.

CART STORAGE

Members paying trail fees for their cart may store their cart in the cart barn from April 1st through March 31st of the following year for a fee of \$250.

Members storing private carts in the cart barn at PRCC shall be assigned a specific parking location. PRCC staff will retrieve the cart from the barn for the member when staff is available to do so. If no staff is available, the member is authorized to enter the cart barn to retrieve the cart from its storage location. Upon completion of use, the cart may be left outside of the cart barn and PRCC staff will clean it, return it to its storage location, and activate the recharge mechanism. The term “cleaning” shall mean cleaning the cart in the same manner as is completed upon PRCC carts, to wit; removal of dirty towels and trash items and rinsing the cart flooring. Members desiring additional cleaning or service to a stored cart may make arrangements for that work with PRCC staff and pay any agreed upon fee directly to that staff person. PRCC shall not be responsible for loss or damage to the cart or its contents for any reason whatsoever. Members are advised to maintain appropriate insurance upon their carts to protect themselves from such possible damage or loss.

PINE RIVER COUNTRY CLUB DRESS CODE POLICY

Pine River is a private country club operating with certain rules and regulations to maintain a facility for all of our members and guests to be proud of and respect. We have established the following dress code regulations that all must follow:

Golf Course and Practice Areas Dress Code:

No tee shirts allowed on the golf course. All golfers need to dress appropriately with a collared shirt. Shirts and blouses with mock turtle collars are allowed.

Jeans that are not torn, dirty, or damaged are permitted on the golf course only before Memorial Day and after Labor Day. Short shorts, halter tops, and sleeveless shirts are not permitted.

Soft spikes or spike-less shoes are required at all times.

Clubhouse & Patio Dress Code:

Shirts/Tops: All styles of shirts and blouses are permitted so long as they have proper sleeves and cover the midriff area.

Pants/Shorts/Bottoms: Jeans are permitted so long as they are not torn, dirty, or damaged.

Footwear: All shoes worn inside the clubhouse must be either spike-less or have soft spikes. Footwear must be worn at all times inside the clubhouse.

MISCELLANEOUS

SINGLE MEMBERSHIP – Includes only the named Member.

FAMILY MEMBERSHIP – Includes the named Member, spouse or live in partner, children (including step-children or exchange students) under the age of 26 on January 1st and residing in the Member's home or attending college or trade school.

NON-RESIDENT MEMBERSHIP – Persons whose primary residence is located more than a 35-mile radius from PRCC shall be considered as “non-residents” of Central Michigan and may maintain either single memberships or family memberships at the reduced dues rates established by the Board of Directors. Non-Residents with single or family memberships shall have all of the rights and obligations of regular memberships.

DIRT BAGS – Persons other than PRCC Members may participate in the Tuesday night “Dirt Bags” event a maximum of two times per year. Such guests must sign in at the clubhouse and pay a green fee of \$15 and cart fee of \$9 if not riding in a Member owned cart. Dirt Bag guests may only play the 9-hole Dirt Bag event. No extra play either before or after the event shall be allowed. Participation as a guest at Dirt Bags, however, shall not count against the three-time limit in effect for regular guest policy.

CHARGING PRIVILEGES – All Members will be assigned a Membership number for billing purposes. A Member wishing to charge cart expenses, event participation expenses, guest fees, food, or beverages shall provide PRCC staff with their membership number at the time the charges are made. Before leaving PRCC property, Members are expected to review their charges for accuracy and sign appropriate charge slips. Leaving the premises without doing so shall conclusively determine that the charges are accurate and shall not be subject to future dispute. All unsigned charges for food and beverages shall incur an automatic 20% tip. Members purchasing beverages from the on-course beverage cart shall check in with PRCC staff upon completion of play to verify that on course charges are accurate. Failure to do so shall conclusively presume accuracy and shall be subject to an automatic 20% tip.

BENEFITS OF REGULAR MEMBERSHIP

Members of PRCC shall be entitled to use of the course facilities at all times the course is open for play. Members shall be entitled to bring any desired guests to PRCC for golf up to 3 times (3 different days regardless of number of holes played) in any given year. Participation in social events such as Jimmy Buffett or Member/Guest does not count against this 3 time limit. Members or their guests shall be responsible for the payment of regular green fees and shall register all guests at the main desk. Any given person may be a guest at Pine River Country Club only 3 times per year regardless of which member may be providing them access. It shall not be necessary for the Member to be present when the guest is using club facilities. Members shall be responsible to see to it that guests comply with all rules and regulations of Pine River Country Club. Persons maintaining family memberships shall be entitled to bring their grandchildren under the age of 16 years to PRCC for golf so long as one or both grandparent members accompany the grandchildren at all times. There shall be no green fees charged for the grandchildren to play and they shall not be restricted in the number of times they can use PRCC facilities. Grandchildren under the age of 10 shall not be subject to cart fees if riding with a grandparent. Grandchildren between the age of 10 and 16 shall be responsible for regular cart fees. Members bringing their grandchildren to the Club under these arrangements shall register them in the main office before play irrespective of the fact that they are not limited by the guest rules.

BUSINESS MEDALLION MEMBERSHIPS

Companies with more than 5 paid employees, members, owners, or officers, may apply for a Pine River Country Club Business Medallion Membership to entertain guests or reward Designated Employees through the enjoyment of golf on one of Central Michigan's premier golf courses. Qualification for Medallion Membership shall be subject to approval by PRCC Board and may be rejected if the Board determines, in its sole discretion, that the applicant is not a legitimate business entity but has been created or maintained primarily for the purpose of obtaining access to PRCC facilities at membership rates less than otherwise applicable to the proposed users.

The term “Medallion Holder” refers to the Company, not an individual. The Medallion Holder may list up to 6 of its owners, members, officers, or employees as its “Designated Employees” making them eligible to play golf at any time Pine River Country Club is open for regular play. The Medallion Holder can authorize one or more of these Designated Employees to bring up to a maximum total of 3 guests per day to Pine River Country Club for a round of golf at green fee rates of \$20 per 9 holes and \$37 per 18 holes. Guests, however, must actually be accompanied by one or more of these “Designated Employees” when using Pine River Country Club facilities. Designated Employees bringing guests to Pine River Country Club shall be responsible to see to it that guests comply with all rules and regulations of Pine River Country Club.

The cost of an annual Medallion Membership is \$6,500 payable in full before April 1 of the membership year. The Medallion Holder may add up to 4 additional Designated Employees at a cost of \$975 per person.

“Designated Employees” themselves will have no usage limit. Guests of Designated Employees, however, are allowed a maximum total of 3 visits per year. Such limit of 3 visits per year shall apply irrespective of whether the guest is a guest of a Designated Employee or of a regular Pine River Country Club Member. All guests must be registered in the Clubhouse where a record of attendance will be maintained. All Designated Employees and their guests choosing to use a PRCC golf cart will be charged normal cart rental rates for that usage. Provided, however, if the Medallion Holder purchases cart usage certificates, Designated Employees and/or their guests may redeem the certificates rather than paying normal cart rental rates so long as the Medallion Holder authorizes that usage.

The Medallion Holder shall select one of its “Designated Employees” to represent the Medallion Holder in Pine River Country Club events or tournaments. That Designated Employee shall be known as the Primary Designated Member. The Primary Designated Member, and their eligible family members, will be allowed to use Pine River Country Club facilities, participate in social events and tournaments, and exercise guest privileges in the same manner as individuals maintaining regular full family Pine River Country Club memberships. Designated Employees, other than the person named as the Primary Designated Member, may participate in golf leagues but shall not be entitled to participate in Pine River Country Club golf events or tournaments unless specifically authorized to do so by Pine River Country Club management when such events are not otherwise filled by Pine River Country Club’s regular members.

MEN’S 9-HOLE LEAGUE

Men’s 9-Hole League will be conducted on Wednesday evenings at 6:00 p.m., from May 13th to August 19th, weather and course condition permitting. Up to 22 2-man teams made up of qualified PRCC members may participate. Any qualified PRCC Member, as well as the Club Manager, may act as a substitute if a player is unavailable on a given week. Guests may not participate in league. To minimize the difficulties caused by unavailable players, Members may elect to create a 3-person team with 2 of the 3 participating on any given week. The cost of league participation is \$300 per team, which shall include a free buffet meal for that day’s players. There will be no cost adjustment for days when league is cancelled due to weather or course condition.

WOMEN’S 9-HOLE FUN NIGHT

Women’s 9-Hole Fun Night will be conducted on Monday evenings at 6:00 p.m., from May 18th to August 24th, weather and course condition permitting. All qualified PRCC members as well as the Club Manager may participate. Guests may also participate a maximum of two times per year. Such guests must sign in at the clubhouse and pay a green fee of \$15 and cart fee of \$9 if not riding in a Member owned cart. Participation as a guest at Women’s 9-Hole Fun Night, however, shall not count against the three-time limit in effect for regular guest policy. The cost of member participation is \$75 per person. There will be no cost adjustment for days when play is cancelled due to weather or course condition.
